## Data protection regulations for the registration form

*In the registration form we process data on the following legal basis:*

**Information regarding guests and stay:** Data processing according to section 36 of executive order no. 587 of 7/5 2019 adopted pursuant to (the Aliens Act) with a storage period of a minimum of one year and a maximum of two years. Local ordinances regarding city taxes may require longer storage periods.

**Email:** Data processing on the basis of Art. 6 (1) a) GDPR with a storage period until revocation of consent.

*You have the following rights according to the General Data Protection Regulation (GDPR):*

**Right of access:** According to Article 15 GDPR you have the right to know whether we are processing your personal data, and to a copy of that data.\*

**Right to withdraw your consent:** Where we process your personal data based on your consent you have according to Article 7 GDPR the right to withdraw that consent at any time without reason.\*

**Right of objection:** If the processing of your personal data is necessary to protect the legitimate interests of our company, you can object to the processing at any time in accordance with Article 21 GDPR.\*

**Right to erasure:** According to Article 17 GDPR this right, often referred to as the right to be forgotten, allows you to ask us to erase personal data where there is no valid reason for us to keep it.\*

**Right to rectification:** According to Article 16 GDPR you have the right to have any incorrect personal data corrected or completed if it is incomplete.\*

**Right to restrict processing:** According to Article 18 GDPR you have the right to ask us to restrict processing of your personal data.\*

**Right to data portability:** Under Article 20 GDPR, you have the right to move, to copy or to transfer your personal data. You will receive your personal data provided in a structured, common and machine-readable format.\*

**Right to lodge a complaint with a supervisory authority:** You have a right of appeal to the competent supervisory authority under Article 77 GDPR.\*
